
# What will my impact be?

# **Trip Notes**

# The travel for this adventure will be operated by Flight Centre.

#### B=Breakfast L=Lunch D=Dinner

This trip combines the best sites of Peru, a visit to a local project in both Lima (Cochlear Clinic) and Cusco (Peru's Challenge), plenty of time to acclimatise whilst exploring scenic Cusco and the Sacred Valley of the Incas, a challenging yet manageable trek through the stunning Lares valley, visiting local communities, hot-springs and several interesting Inca ruins on route, and finally we catch the spectacular train down to Aguas Calientes for a full day of exploring the magnificent Machu Picchu - the 'Lost city of the Incas'. We return to Cusco for a final day of exploring, shopping and fine dining before heading back to Lima and our onward connection.

### DAY 1: 2 June **Arrive Lima**

On arrival at Lima Airport you will be transferred to your hotel in Miraflores. Dinner is provided in your hotel tonight. (D)

### DAY 2: 3 June Lima

Today you will be picked up by an English speaking guide and private vehicle to visit the Cochlear Clinic in Miraflores. After this your guide and vehicle are available to take you shopping or to visit the coast / look around Lima. Coordinate with your guide for options. (B)

### DAY 3: 4 June Lima - Cusco

This morning we have an early morning transfer back to the airport to board the flight along the Andes to Cusco where you will be met by your Amazonas Explorer guide and transferred to our hotel in central Cusco. Today is for acclimatisation to the exalted air of the Andes (3,240m).

Drink plenty of liquids and take it easy. After lunch in a typical local restaurant we take a short walking tour of central Cusco. (B,L)

# DAY 4: 5 June Peru's Challenge school

Today we visit the village Peru's Challenge is working with, located just outside of Cusco. Here we will have a real, first hand experience of project work in Peru . (B,L)

# DAY 5: 6 June **Cusco and Pisac sacred valley** acclimatisation

An essential part of your trip is to spend a day acclimatising whilst enjoying the amazing ruins, markets and scenery of Cusco and the Sacred Valley. This trip leaves Cusco early in the morning. Our first stop is the picturesque Andean village of Pisac. The village is famous for its Sunday, Tuesday and Thursday markets and superb artisan stalls throughout the week. Time can be spent shopping or for the more energetic visiting the extensive Inca ruins at the top of the hill. The old Pisac ruins have much to explore with a circular hike along a well-defined track through royal buildings before returning on another good trail to the bus. We then head back to Cusco for a lovely walking (or vehicle) tour and a superb introduction into the Inca heritage of Peru. At 3,650m this is also a perfect acclimatisation hike for the Lares trek to come.


After a picnic lunch we head back to Cusco, exploring some of Cusco's outlying Inca sites en-route. Ten kilometres out of Cusco is Tambo Machay, popularly called the Inca's Bath due to its finely preserved waterfalls, carefully diverted through fine stone channels. We will also visit the site of Puca Pucara. This delightful ruin on a small prominence is believed not to be the 'red fort' its name suggests but a 'Tambo' - a rest house for travelling animals, goods and travellers.

With Cusco now in our sights we visit the fascinating Qengo. This waca contains some of the finest examples

of Inca carvings in-situ. The eroded limestone fissures have been artfully carved into zig-zag channels (from where Qenqo derives its name), pumas, condors, snakes and houses. Bountiful Mummy Niches in the caves, an amphitheatre and the central phallic column all add to the mystery of its multi-functional use.

Our final and most stunning ruin is the extensive Sacsayhuaman. Although the smaller stones of Sacsayhuaman were used to build modern day Cusco, the remaining stones are up to 8.5m high and weigh over 360 tonnes. The distinctive zig-zag ramparts that form are attributed to being Puma teeth, lightning and also fortification. This major centre obviously had many functions with storehouses, administration buildings, reservoirs and play areas. It was also the site of a crucial battle between the Incas and the Spanish.

Downhill on an old Inca road brings us to San Cristobal church built on top of Inca Manco Capac's Palace and is a fantastic view point of Cusco. The final steps down the streets of San Blas bring us to the Plaza de Armas and the end of the tour. (B,L)

# DAY 6: 7 June Cusco – Quisuarani

Departing Cusco early we descend into the Sacred Valley before, at Calca, heading high into the Andes. In just under two hours we will leave the vehicles and start our acclimatisation hike up an ancient Inca trail, through a narrow canyon where Inca burial tombs can still be seen. This is a perfect hike to allow us to experience first hand affects of trekking at altitude. (Depending how the group is feeling we have the option to continue walking or meet our bus further up the valley). Quisauarani, a 4,200m, is a small community where we will set up base camp for the night. (B,L,D) (approx. 8km walked today)

### DAY 7: 8 June Quisuarani – Cuncani – Huacahuasi

Today we enjoy a beautiful day's hiking as we climb out of the Quisuarani valley, hopefully meeting en route some of the colourfully dressed locals. This whole area is famous for its weavings and at the various campsites we can barter for beautiful handmade textiles at a fraction of the price of what they would be at home or even in Cusco. Our trekking path borders the native tree reforestation project of ECOAN: this restored eco-system is home to several endemic birds. We descend past some spectacular waterfalls and crystal clear lakes to the small village of Cuncani. Here we meet our support vehicle for lunch. The afternoon has many options either a short walk over the ridge to the village of Huacahuasi, a scenic hike down the river, road and an old Inca Trail to the Lares Hot-springs, where after a good soak in the "Banos del Inca" - The Incas's Baths - a selection of perfectly heated pools, our support vehicle can return to camp on Huacahuasi football pitch. Alternatively, if you are feeling low on energy, we could just drive to the hotsprings to recuperate in style. The valleys of Lares have many hidden treasures and are versatile enough to tailor the trek to weather and our needs. (B,L,D) (approx. 18km walked today)

### DAY 8: 9 June Huacahuasi – Patacancha

Now fully acclimatised and rested we set off for our final challenge to climb over a 4,100m pass and descend towards the Sacred Valley of the Incas – we take it realyl slowly, stopping beside beautiful lakes and hope to arrive at the pass just before lunch for spectacular views of the snowy mount Veronica. Recently a pair of condors has settled in the valley and we hope to get a glimpse of these soaring above the mountain ridges. We then descend following an old mule trail to the village of Patacancha where we meet the support vehicle to take us to Huilloc where we camp on a local's field

just outside the village. Huilloc is famous as being the town where many of the traditional porters for the Inca Trail come from: traditional dress is always worn and Quechua is spoken. This is our last chance to barter for more fine weavings. (B,L,D) (approx. 15km walked today)

# DAY 9: 10 June Huilloc – Pumamarca – Ollantaytambo – Machu Picchu

The start of our walk today is a short sharp climb bringing us to the impressive and rarely visited ruins of Pumamarca. After visiting this extensive site, we follow an ancient Inca trail along the many terraces of the Huilloc valley as we wind our way through eucalyptus forests to end our trail nearby the impressive ruins of Ollantaytambo. After lunch, we catch the late afternoon train to Machu Picchu pueblo (formerly known as Aguas Calientes) where we check into our hotel. The evening is free to explore the extensive artisan market and the many colourful bars and restaurants of Machu Picchu town. (B,L) (approx. 7km walked today)

# DAY 10: 11 June Machu Picchu tour and return to Cusco

An early, short bus ride takes you direct to the "Lost City of the Incas - Machu Picchu". Once there, your guide gives you an extensive walking tour of the ruin and explains the fascinating history of the Incas to you. If time permits you may wish to explore further to the Inca Bridge, walk back up the Inca Trail to the sun gate or try the strenuous climb of Machu Picchu Mountain for an awe-inspiring Condor's eye view of Machu Picchu. We have included the permit to climb Huayna Picchu. Some may prefer to just relax and take in the awesome location. We catch an afternoon bus to Aguas Calientes for a late lunch and transfer to the train station from where you catch the afternoon train back to the Ollantaytambo and onto Cusco where we drop you off at the hotel. (B,L) (lots of walking today up and down the ruins, lots of stairs)



### DAY 11: 12 June Cusco

Today is a free day in Cusco for some rest and recuperation. There is so much to see and do in Cusco. Whether your interest is exploring Inca ruins, visiting Colonial churches, bargain hunting in Indian markets or just relaxing over a cappuccino on a terrace overlooking the Plaza de Armas, Cusco has it all. In the evening we meet up for a celebratory dinner and those with the energy can venture on to explore Cusco's excellent nightlife. (B,D).


## DAY 12: 13 June Cusco – home

# **Frequently Asked Questions**

#### How do I fundraise?

Past participants have successfully fundraised in many creative and fun ways. We will send you a comprehensive Fundraising Toolkit upon registration to help you reach your target. You will also have regular support from our Inspired Team, who will help you develop and manage your fundraising plan, as well as support from the charity for which you are fundraising.

#### What does it cost?

Upon registration, you pay a registration fee of \$700. The travel cost and donation to Taralye can be fundraised with the support of Inspired Adventures.

#### Is my donation tax deductible?

The funds raised for the charity are tax deductible (conditions apply). Funds raised to cover travel costs are not tax deductible.

#### What's included?

International airfare departing from Sydney and Melbourne on LAN Airways including taxes, all transport and sightseeing as per itinerary, meals as per itinerary, twin-share accommodation, all camping and cooking equipment including Therm-a-rests, spacious two-person tents, dining tent, tables and stools. An extensive first-aid kit; professional English and Spanish-speaking guides. Support vehicle and support mules whilst trekking one support horse for every ten clients, entrance to Lares Hot-springs, all camping fees and an Inspired Adventures Team Escort.

### What's not included?

Personal belongings, sleeping bag (available for rent at \$10 a night), airport taxes (\$31 international), travel insurance, personal expenses and tips.

#### How fit do I need to be?

This trek is ranked 3.5/5. It involves trekking or climbing for up to 6-7 hours a day for 5 or more days at a steady pace with difficult stages lasting either a few hours each day or a few days of the entire trip. You will be expected to carry a daypack containing basic items needed on the day that should weigh 5-7kgs. You will need a good level of fitness and be in good health. Our adventures are specifically designed for people who are relatively fit and willing to train. On our treks and cycle adventures, we take things slowly and steadily, managing the various fitness levels and abilities of our groups. We can't think of a more exciting fitness goal! Go for it!

### Can I extend my stay?

Of course, many of our participants decide to extend their stay to get the most from their overseas adventure! (Additional travel arrangements are at your own cost).

### What is the general age range of participants?

The minimum age is 16 years old when accompanied by an adult. We have had participants of all ages from 16-70 years, all united by their sense of adventure.

### How do I register?

This Inspired Adventure is operated by Flight Centre Ltd.

Please read carefully the terms in the conditions of contract in completing and submitting the Booking Form. you agree to be bound by these conditions which constitute the agreement between Inspired Adventures, Flight Centre Ltd (Flight Centre) and you. The conditions apply to the exclusion of any other terms or conditions unless they are set out in the Booking Form, or are otherwise agreed to in writing by the parties. Previous dealing with the parties will not vary these conditions. No purported variation of these conditions will be effective unless in writing and signed by a person so authorised by Inspired Adventures and Flight Centre.

- 1. How to Book: To participate in this Inspired Adventure, you must pay a non-refundable registration fee of AUD\$700 including GST payable to Inspired Adventures. Six weeks later you must pay a non-refundable travel deposit of AUD\$400 including GST which must be made payable to Flight Centre. If you register within 4 months of the departure date you must pay the travel deposit of AUD\$400 immediately upon registration.
- 2. Payments and Fundraising: Eligibility to take part in this Challenge is contingent upon you raising the minimum Fundraising Target. Flight Centre will not accept receipt of your balance payment until there is evidence that your Fundraising Deposit of AUD\$1,000 has been met 20 weeks prior to your departure. The balance of your Fundraising Payments must be made no later than 4 weeks prior to your departure. Travel costs are based on arrangements departing from the published departure city/cities in Australia and exclude travel insurance & visa fees. Flight Centre may be able to arrange travel from other cities in Australia, a surcharge will apply. Registered participants will be required to cover additional travel or accommodation costs required as a result of departing from an alternative destination. Failure to lodge the fundraising target on or before the required date will render you ineligible to depart on the Challenge and you will forfeit in full the AUD\$700 registration fee paid to Inspired Adventures, the AUD\$400 travel cost deposit paid to Flight Centre, and your place on the adventure. All monies raised in the name of the **charity** must be forwarded immediately to the **charity** along with supporting documents as outlined in the 'Conditions of Fundraising'. Inspired Adventures, Flight Centre, and the charity reserve the right to refuse your Application to Register. Their decision is final and binding. Should your Application be refused your full registration fee will be refunded to you. Your registration for the Challenge will take effect once your registration funds have cleared. Places are limited on the Challenge and are allocated on a first come first served basis.

#### Prices:

All prices are subject to availability and can be withdrawn or varied without notice. The price is only guaranteed when paid in full. Please note that prices quoted here are subject to change and will be re quoted at the time of full payment. Price changes may occur by reason of matters outside our control which increase the cost of the product or service. Such factors include adverse currency fluctuations, fuel surcharges, taxes and airfare increases. Please contact your Consultant

#### Refunds, Changes and Cancellation Fees:

We are unable to provide a refund to you until we receive the funds from the relevant supplier. Cancelled bookings will incur charges. These charges can be up to 100% of the cost of the booking, regardless of whether travel has commenced. Fees and extra charges will apply where a booking is changed. Fees and extra charges will also apply when tickets or documents are re-issued. Where we incur any liability for a cancellation fee or charge for any booking which you cancel, you agree to indemnify us for the amount of that fee or charge.
